

**POUOVER WILL OF MALCOLM B. MIDDLE**

**Part 1 – Statements**

- 1.1 I, MALCOLM B. MIDDLE, of NASHUA, NH, after careful thought, declare this to be my Will and revoke all prior Wills.
- 1.2 I recognize the uncertainty of this life; am fully confident and trusting in my Lord and Savior, Jesus Christ, in His death for my sins on the cross, and in His shed blood as an atonement for my soul; and know that by faith in His sacrifice on the cross for me I have eternal life.

**Part 2 – Personal Representative**

My Personal Representative Shall Handle Both Physical & Digital Assets: The person below (listed in order of preference) shall be my Personal Representative. My Personal Representative shall have all the powers, and shall be subject to duties, listed in NH RSA 564-B:8-815 & 816 (NH Trustee Powers,) as well as NH RSA 554-A (Digital Assets.)
